The San Jacinto College Facial/Esthetic Specialist certificate program provides students with the skills and knowledge necessary for an entrylevel position in the facial/esthetics profession. Upon successful completion of 750 classroom and lab training hours, the student is eligible to take the written and practical exams regulated by the Texas Department of Licensing and Regulations in Facial/Esthetics.
